**Transition to Retirement Pensions – Important changes to apply from 1 July 2017**

As a result of the superannuation reform package that was announced in the 2016 Federal Budget and legislated in November 2016, a change to the tax treatment of Transition to Retirement Pensions (TTRs) was introduced which means that TTRs will not be considered retirement phase income streams from 1 July 2017. Prior to this change, all assets supporting retirement income streams were tax-free, i.e. they were exempt from the 15% tax applied to earnings in superannuation accounts.

This means that with effect from 1 July 2017 earnings from assets held in TTRs will be taxed at 15%.

***What does this mean for you?***

**To implement this change, the Fund will automatically switch the assets held in your TTRs from the tax-free (retirement phase) investment options to the taxed (accumulation phase) investment options with effect from 1 July 2017.**

It is important to note that other than the changes to your investment options, no further changes will be made to your TTR pension account in the Fund.

Your investment options will be mapped in accordance with the current asset allocation, e.g. 100% Aggressive option in the retirement phase will be moved to 100% Aggressive option in the accumulation phase.

The characteristics of the Fund's investment options, such as the strategic asset allocation, investment objective, minimum suggested timeframe, etc., are the same for both the retirement phase and accumulation options. There is no change in fees and costs.

**What if I have satisfied a condition of release?**

If you have permanently retired from the workforce, reached age 65 or if you have satisfied another condition of release, we can move your assets from a TTR account to an Account based pension account. This will mean that your investment earnings will remain tax free. Please refer to the Pension Product - Product Disclosure Statement (PDS) for further information about conditions of release. This PDS is available on the Plan's website at [www.ascsuper.com.au](http://www.ascsuper.com.au).

If you have satisfied a condition of release, please let us know by 28 June 2017 by filling out the attached form and returning it to us.

## What if I satisfy a condition of release after 1 July 2017?

If you satisfy a condition of release after 1 July 2017 then please let us know as soon as possible after that date so that we can convert your TTR Pension to an Allocated Pension.
