Transition to Retirement pension accounts (TRP): The table above shows the historical returns for TRP investment options taxed at the concessional superannuation tax rate of up to 15%. Please note that TRP accounts were untaxed (i.e. tax exempt) prior to 1 July 2017. This means that 7-year and 10-year performance returns shown here are only an indication and may be slightly understated compared to what your TRP account may have earned (if it commenced before 2017).
